



Terms & Conditions for 1881 Tullimbar 2024 Christmas Lights Competition by Dahua

The following are the terms and conditions for the “1881 Tullimbar 2024 Christmas Lights Competition” by Dahua (“Competition”) in November/December 2024.

Adjudicator	An employee or agent of the Promotor who has been appointed by the Promotor to judge the 1881 Tullimbar Christmas Lights Competition.
Eligible Entrant	An entrant participating in the 1881 Tullimbar Christmas Lights Competition who, at the sole discretion of the Promotor and the Adjudicator, satisfies the requirements of PART A of these terms and conditions.
Eligible Entries	An entry by an Eligible Entrant.
Eligible Prize Winner	An Eligible Entrant entitled to receive a Prize in accordance with these terms and conditions.
First Prize	\$300 Woolworths Gift Card
Second Prize	\$200 Woolworths Gift Card
Third Prize	\$150 Woolworths Gift Card
1881 Tullimbar Christmas Lights Competition	This competition which is governed by the terms and conditions set out herein.
Prize	A collective reference to the First Prize, Second Prize and Third Prize.
Competition Period	The period commencing at 5pm on 15/11/24 and ending at 5pm on 15/12/2024
Promotor	Dahua Group Sydney Project 6 Pty Ltd ABN 66 621 537 362 of Suite 2, Level 20, 201 Elizabeth Street, Sydney NSW 2000 (“Promoter”)

PART A – Entry into the Promotion

1. To validly enter, an Eligible Entrant must, during the Promotion Period:

- a. Be a resident of 1881 Tullimbar and ensure all Christmas decorations and lights are contained within the property boundary.
- b. Complete and submit the [2024 CHRISTMAS LIGHT COMPETITION ENTRY FORM](#), including at least one image of your house light display at 1881 Tullimbar with home resident(s) in front of the house, before 5:00 pm on December 15th, 2024.
- c. Each Eligible Entrant is permitted one entry.
- d. Entries containing offensive content, as determined by the Promoter in its sole discretion, will not be accepted.
- e. The time of entry will be considered the time it is received by the Promoter.
- f. Satisfy any other requirements specified by the Promoter.

2. By participating in the 1881 Tullimbar Christmas Lights Competition, an Eligible Entrant confirms acceptance of the terms and conditions outlined herein.

PART B – Judging of Entries

3. Judging will be conducted by the Adjudicator at their sole discretion, on December 16, 2024. Winners will be notified on December 19, 2024, via social media, phone, and/or email.
4. Eligible Entries will be judged based on creativity.
5. The Adjudicator's decision will be final, and no correspondence will be entered into.
6. Chance plays no part in determining the winning entry.

PART C - The Prizes

7. The Eligible Entrants whose Entries are judged as the best shall receive the First, Second, and Third Prizes.
8. No compensation will be payable if an Eligible Prize Winner is unable to receive, redeem, or use the relevant Prize.
9. Prizes are not exchangeable or redeemable for cash or other goods or services, and gift cards for first, second, and third prizes will be provided by the Promoter.
10. A Prize cannot be transferred to any other person without the express written consent of the Promoter.
11. If the Prize (or any part of the Prize) is unavailable, the Promoter reserves the right to substitute the Prize (or that part of the Prize) with a Prize of equal value and/or specification.

PART D - Promoter Rights and Limit of Liability

12. The Promoter is not responsible for any lost, late, or misdirected entries.
13. The Promoter reserves the right, at any time, to verify the validity of entries and Eligible Entrants (including an entrant's identity, age, and place of residence) and to disqualify any entrant who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
14. The Promoter reserves the right to share any media in submissions on the website, social media, and in any other promotional material.
15. By entering the competition, you hereby grant Dahua Group Australia and any of its affiliated companies the irrevocable right and permission to use the submitted photograph(s) for the purposes of promotion.
16. The Promoter reserves the right to at any time amend, vary or change (without reference or notice to an Eligible Entrant or any other party):
 - a. The Prize.
 - b. Any term or condition contained in these terms and conditions.
17. Failure by the Promoter to enforce any of its rights at any time does not constitute a waiver of those rights.
18. Except for any liability that cannot be excluded by law, the Promoter (including the Adjudicator, its officers, employees, and agents) excludes all:
 - a. Statutory liability.



b. Representations, conditions, and warranties implied by custom, the general law, or statute.

c. Liability for negligence, any personal injury, and any loss or damage whether direct, indirect, special, or consequential (including economic loss, loss of revenue, loss of opportunity, loss of goodwill), arising in any way out of the 1881 Tullimbar Christmas Lights Competition, including, but not limited to:

i. any variation in value in the event that Prizes are replaced in accordance with these terms and conditions.

ii. any tax liability incurred by an Eligible Entrant; or

iii. use of the Prizes.

PART E - Notification of the Winner

19. The winner of the First, Second, and Third Prizes will be notified by the Promoter and/or Urban Land Housing by 5:00 pm on December 19, 2024, via social media, phone, and/or email. Instructions for Prize redemption will be provided by the Promoter thereafter.
